This year we have taken some big steps. We have partnered with St. Francis Xavier Catholic Church to expand our services in Eastland County to **help more of our neighbors in need**. This includes Working Family Services, a financial coaching program, and Parish Social Ministries, which connects those in need to supportive services and resources.

We also **expanded the Gabriel Project** to Sacred Heart Parish in Wichita Falls. Gabriel Project is a CCFW parish-based ministry that pairs trained volunteers - or Angels - with women in crisis pregnancies. Angels accompany mothers throughout their pregnancy and beyond, providing spiritual, emotional, and practical support.

Moreover, I am proud to say that, as of the end of 2022, we have moved **more than 4,200 families** onto a meaningful pathway out of poverty through our research-backed services. From students who have earned an education credential to pursue their dream career to single parents who have strengthened their long-term financial resiliency, this number represents **countless milestones** and **obstacles overcome** by the resilient and resourceful clients we serve.

We ask you to join us in celebrating the journey to get here today, and to keep the most vulnerable among us in your hearts and minds. Education Pathway

We help students **navigate non-academic barriers** to complete their educational goals and increase earnings.

"If you invest in your education, you'll never be stuck."

Reina Gomez wanted to be a nurse ever since she became a mom. However, multiple non-academic barriers got in her way - from a marital separation to a house fire. Catholic Charities supported Reina through her nursing program, providing strategic financial assistance and helping her connect to resources every step of the way. Reina's Navigator walked the journey with her, helping her budget, connecting her to counseling, and ensuring she accessed all necessary resources when she lost her home. Reina successfully graduated as a Registered Nurse in December 2022.



Emotional Resiliency Pathway

We help people **navigate emotional trauma** and **stress** to increase their ability to cope with adversity and plan for a better future.

579 CLIENTS SERVED ON THE PATHWAY IN 2022.

To refine our understanding of our impact on emotional resiliency, we conducted a preliminary survey of long-term case management clients, who reported a **15.5% increase** in their ability to cope and a **17% increase** in their ability to plan after completing our services.

Through Catholic Charities' long-term case management, Ana Jasso achieved several financial goals, including reducing her debt and re-starting her small business. However, when her husband passed away from COVID-19, she found herself struggling to manage. Catholic Charities helped her access counseling and provided the individualized support she needed to navigate a time of loss and grief - and to maintain her long-term progress.

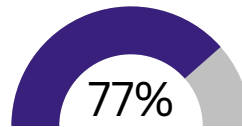


Employment Pathway

In 2022, CCFW implemented a new Learning Management System that offers **on-demand trainings** to support clients' coaching sessions along the Employment Pathway. Clients can also take trainings to build skills and competencies for their resumes (e.g. communication, Microsoft Office).

DaAliyah came to CCFW through our Gabriel Project program in 2022. After providing initial support including items for her new baby and transportation assistance, we referred her to CCFW long-term case management. Her goals were to become a Certified Nursing Assistant (CNA) and to build her savings.

Our employment program helped DaAliyah secure funding for a CNA training course at James L. West Center for Dementia Care. Upon completion, she accepted a lead position there. In addition, with CCFW's assistance, DaAliyah applied and was recently accepted to the University of North Texas' Community Health Worker (CHW) training program. She expects to complete her training in June of 2023 and use this certification to elevate her career growth.



Financial Resiliency Pathway

We help people **navigate their finances** to bolster savings, absorb shocks, and realize their long-term financial goals.

Jasmine, single mother of two, came to CCFW after losing her job, in need of transportation and on the verge of losing her childcare. With the help of her case manager Nikki, Jasmine increased her credit score by 120 points, **saved almost \$10,000** in a year, and moved into a better home for her family.

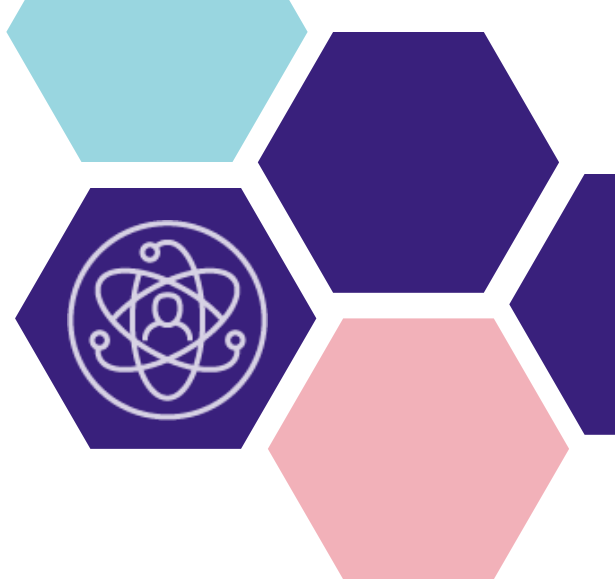

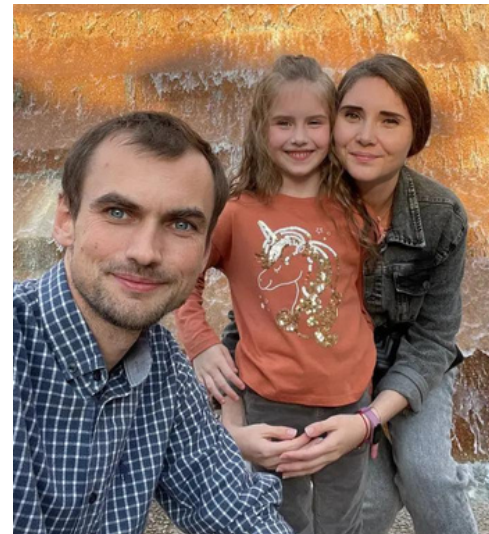

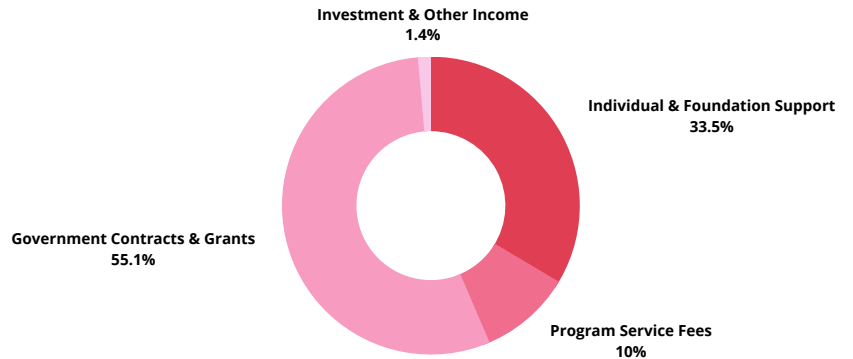
